In this context, CRISIL confirms the following:



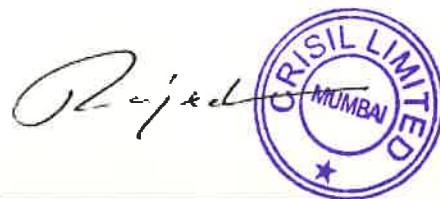
