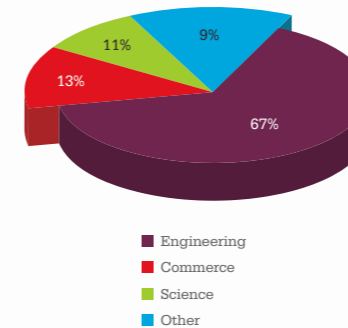

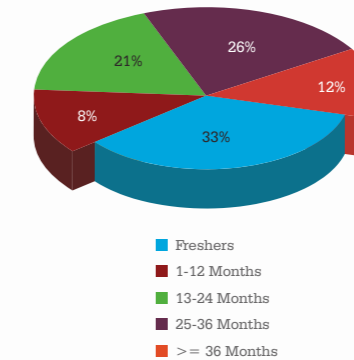

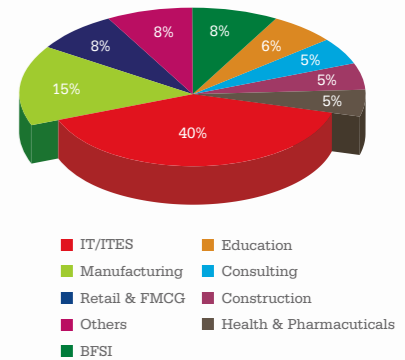

The campus played host to two international companies. These companies recruited 13 students who will have a unique opportunity to intern outside the country.

As a part of this the students will be supported by the institute and corporate mentors throughout the process. 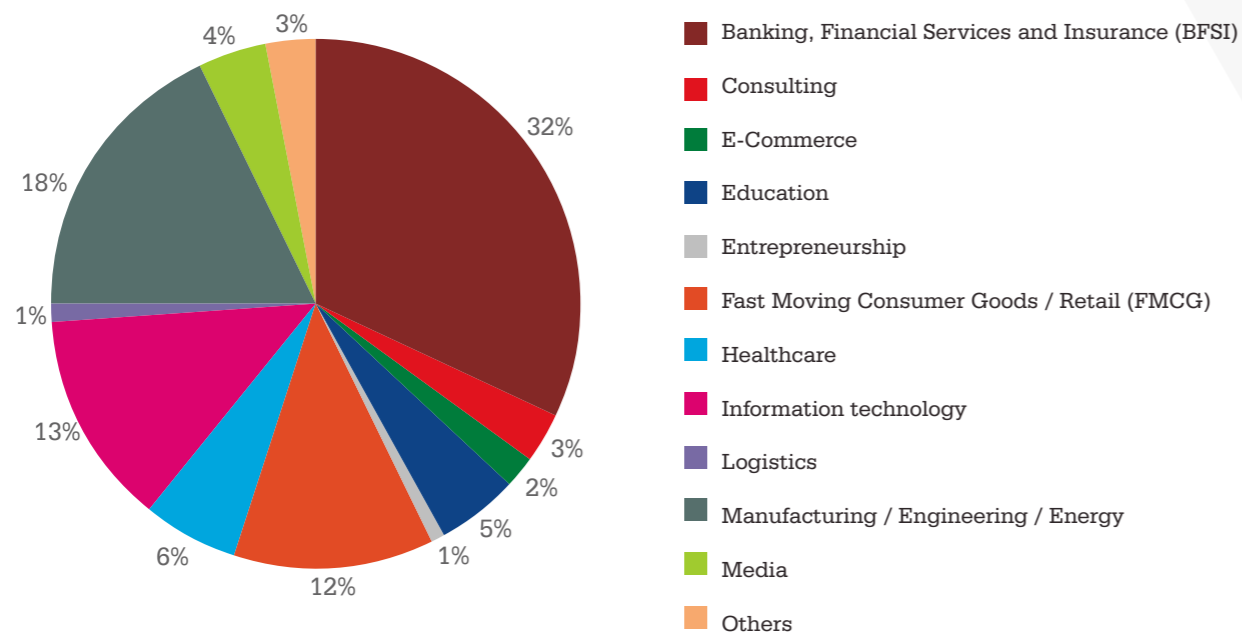

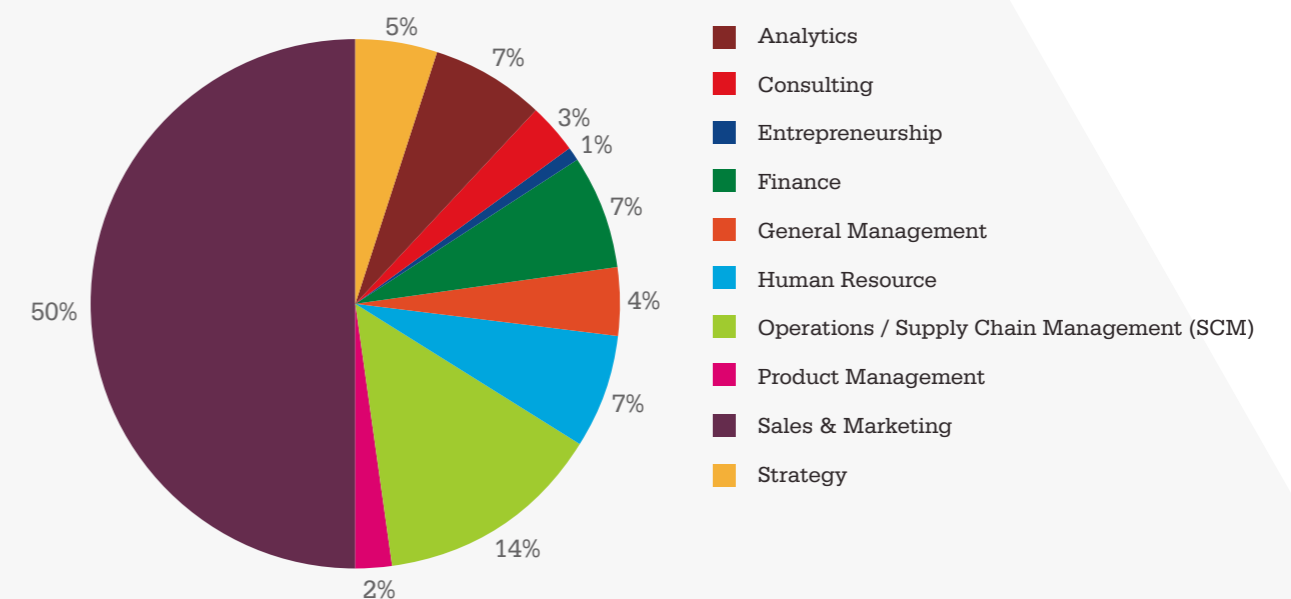
Classification by Sector for 219 Students
