Re: Audit of the Placement Report of the 2010-12 Master of Business Administration (MBA) programme

We have audited the Placement Report prepared by you for the summer placements of students of the 2010-12 batch of the Master of Business Administration (MBA) programme of Symbiosis Centre for Management and Human Resource Development (SCMHRD), Pune. The Placement Report is the responsibility of SCMHRD. Our responsibility is to validate the information provided in the report with the relevant documentation, and comment on the Placement Report's conformance with the Indian Placement Reporting Standards (IPRS).

In this context, we confirm the following:

1. For the purpose of the audit, we have obtained all the information and explanations, which to the best of our knowledge and belief were necessary. In our opinion, the Placement Report complies with the Indian Placement Reporting Standards.
2. The validation of information presented in the report is based on communication received by SCMHRD from recruiting companies. CRISIL has not independently sourced any information or documentation.
3. We have verified the information with respect to remuneration presented in the report with communication received from recruiters. Information regarding compensation received from individual students has not been used.
 - a. Where offer letters or other recruiter communication was not available, the report considers the record as data unavailable. We have not been able to verify the status of such students since there is no record.
 - b. The information has been categorized as best as possible under different salary heads as given in the IPRS: where a break-up was not available, the salary has been considered only as 'Maximum earning potential'.
4. The number of students opting out of the placement process has been established through written communication from the student who has opted out.
5. In general, CRISIL was not able to verify the job function and location. In such cases, the information shared by students with the institute has been included in the report.

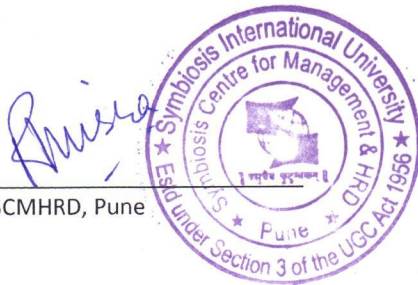
